



Supplement 1 - Interview with KH

Document Details:

1. As previously reported on 09-23-2024, I, Texas Ranger Cody Rogers, began this investigation. I arrived at the Colorado County Sheriff's Office (CCSO) and met with Chief Deputy Justin Lindemann and Lieutenant Andrew Weido. Prior to my arrival, Lieutenant Weido collected evidence to include smoked cigarettes and a 12-ounce Dr. Pepper can. Note: this evidence will be documented in a subsequent report.
2. Chief Lindemann provided a brief overall of the complaint against CCSO Sergeant Tomas Ramirez. I was told Sergeant Ramirez, while on duty and in uniform, removed KH (Pseudonym) from the jail on Sunday, 09-22-2024. Sergeant Ramirez and KH walked to the patrol sergeant's office, and the two engaged in deviant sexual intercourse. KH drank from a soda can and smoked cigarettes during this time. KH returned to the jail cell after approximately one hour.
3. Chief Lindemann and I walked inside the control room (picket) at the jail and reviewed camera footage from Sunday, 09-22-2024. At approximately 9:49 PM, I observed Sergeant Ramirez escorting KH from the jail and the two walking into the hallway. Note: the jail videos on 08-29-2024 and 09-22-2024 will be documented in a subsequent report.
4. KH was escorted to the interview room by the CCSO jail staff. Chief Lindemann and I interviewed KH regarding the allegations against Sergeant Ramirez. The interview was audio and video recorded, and a digital recording device was used as a backup. The following is a summary of our conversation, which does not necessarily reflect all statements made or order of occurrence:
 - A. The interview with KH began at approximately 11:36 AM. KH provided details on her current incarceration, which stemmed from a previous charge of being in possession of methamphetamine. KH mentioned an email Sergeant Ramirez allegedly sent in reference to narcotics related activity in Colorado County. KH was arrested, then booked into the Colorado County Jail on 08-29-2024, and has

been incarcerated since. KH detailed an incident regarding a jailer upon her incarceration on 08-29-2024. KH stated the jailer gave her a hug when she arrived inside the jail.

- B. When KH arrived at the jail on 08-29-2024, Sergeant Ramirez pulled her from the jail and walked her to the sergeant's office. Sergeant Ramirez locked both doors, pierced out the window, then checked locations of the on-duty deputies. Sergeant Ramirez and KH discussed the dollar amount on her bond. KH viewed the deputy's locations on Sergeant Ramirez's computer. Sergeant Ramirez grabbed KH's breasts as the two were by the computer. KH knew what Sergeant Ramirez was wanting, so the two engaged in deviant sexual intercourse. KH stated she gave him a blow job and afterwards, the two talked for a brief moment. KH then went back to the jail. KH clarified that Sergeant Ramirez fondled her breasts. KH said Sergeant Ramirez unzipped his pants and pulled out his penis. After ejaculating, Sergeant Ramirez wiped his pants to remove his semen. KH said Sergeant Ramirez was bothered if the jailers observed semen on his pants. I asked KH if the deviant sexual intercourse was consensual, and she replied, "I mean, I was just doing what I thought I had to do." KH said Sergeant Ramirez wore his vest and duty belt. KH believed no body worn camera or recording device was activated during her encounter with Sergeant Ramirez. KH did not tell anyone about this incident with Sergeant Ramirez.
- C. On 09-22-2024, a jailer approached KH's cell and told her Sergeant Ramirez wanted to see her. Note: KH did not request to speak with Sergeant Ramirez. KH and Sergeant Ramirez went into the sergeant's office. KH sat in the chair inside the sergeant's office, and KH stated Sergeant Ramirez offered her marijuana. KH maneuvered the computer's mouse and checked the locations of the on-duty deputies. Sergeant Ramirez touched his penis and rubbed his private area to dismiss his erection. Sergeant Ramirez received a telephone call and answered the call in the patrol room. A pack of cigarettes was in Sergeant Ramirez's desk drawer. During the night, KH smoked a total of two cigarettes. Sergeant Ramirez removed his vest and duty belt after the two entered the sergeant's office. Sergeant Ramirez touched or grabbed KH's leg as the two sat close to one another. KH asked Sergeant Ramirez about his home life.
- D. KH described in detail a time when she was assaulted by her ex-boyfriend. Sergeant Ramirez offered KH a shower at the water park in Sheridan, Texas, after the assault. KH said Sergeant Ramirez grabbed a pack of Marlboro Special Select cigarettes from his desk drawer after he touched her leg. KH flipped one cigarette and returned the cigarette to the pack. KH grabbed a cigarette to smoke and then went outside the side door at the CCSO. KH smoked one cigarette and then walked back to the sergeant's office. Sergeant Ramirez talked on his cell phone and KH looked a second time at the deputy's locations. Sergeant Ramirez unzipped his pants and began masturbating himself. KH and Sergeant Ramirez engaged in deviant sexual intercourse. KH told me she gave Sergeant Ramirez a blow job. Sergeant Ramirez ejaculated in her mouth as she was on her knees, and he sat in the chair. After ejaculating, Sergeant Ramirez put his duty belt and vest back on. Sergeant Ramirez told KH he would email the narcotics deputy about her information. KH drank a Coke before and after the deviant sexual intercourse. KH believed semen was still in her mouth, and on the

second cigarette, she smoked. KH described in detail the layout and items in the sergeant's office.

- E. KH returned to her jail cell and took a shower. Other inmates in close quarters to KH were questioning why KH would be pulled from her cell late at night. On 09-22-2024, KH stated when she was bent over, looking at Sergeant Ramirez's computer, he approached her from her back side and rubbed his penis on her anus, then reached and grabbed her breasts. During this encounter, Sergeant Ramirez was talking on his cell phone. Sergeant Ramirez, while still on his cell phone, pulled his penis out and began to rub and stroke his penis. KH performed oral sex on Sergeant Ramirez, and after he ejaculated, he put on his vest and duty belt. KH smoked a second cigarette, went back to Sergeant Ramirez's office, then was escorted back to the jail. KH observed Sergeant Ramirez checking his pants to make sure nothing was noticeable.
 - F. Sergeant Ramirez told KH not to tell anyone about their sexual encounters. I questioned KH about her interactions with Sergeant Ramirez while outside of custody and she explained he provided her information as to the whereabouts and locations of the on-duty deputies while she had warrants for her arrest. Previously, when KH had a fight with her boyfriend and ended up at the cabins at Splashway to take a shower, Sergeant Ramirez and KH had sexual intercourse. Sergeant Ramirez pulled out and ejaculated on KH's stomach. After sex, Sergeant Ramirez asked KH if he could touch her breasts, in which she obliged. During this encounter, Sergeant Ramirez was working off duty, in uniform, at Splashway Waterpark. KH believes Sergeant Ramirez has something to do with her pending criminal case and is not speaking on Sergeant Ramirez for any reduction in time.
 - G. KH and Sergeant Ramirez would communicate with one another through cell phone use. KH described a second encounter where she and Sergeant Ramirez had sexual intercourse. Sergeant Ramirez, while on duty, picked KH up by the post office in Rock Island, Texas. The two traveled down a back road and stopped. Sergeant Ramirez gave KH \$60.00 in cash, and the two exited. Upon exiting, Sergeant Ramirez and KH had sex on the side of his marked unit, standing up. KH corrected herself and stated Sergeant Ramirez didn't pick her up by the post office but rather the bus stop.
 - H. KH placed a piece of paper on the desk and provided cell phone number 979-942-7551. The paper contained the cell phone number used by Sergeant Ramirez. KH provided written consent to look through and download her cellular telephone. Note: a copy of the consent form is included as an attachment to this supplement. KH was never physically attracted to Sergeant Ramirez. KH affirmed the incidents with Sergeant Ramirez occurred as stated.
5. The conversation with KH concluded. For additional and complete details, refer to the recorded interview. The audio/video and audio only recording, will be kept in the master file of this investigation. KH was escorted back to the jail.
6. Additional investigative efforts will be documented in subsequent reports.

1. On 09-23-2024, I, Texas Ranger Cody Rogers, and Colorado County Sheriff's Office (CCSO) Chief Deputy Justin Lindemann interviewed CCSO Sergeant Thomas Ramirez, H/M, [REDACTED], regarding the allegations set forth against him. The audio/video recorded interview was non-custodial and voluntarily. A back up digital recording device was also used to capture our conversation. The following are my notes from the interview, which does not necessarily reflect all statements made or order of occurrence.
 - A. The recording began at approximately 2:14 PM. I let Sergeant Ramirez know the interview was voluntarily and he was free to leave at any time. I explained the allegations made against him and let him know how I was involved with the investigation. Sergeant Ramirez stated the jailers knew he wanted to talk with KH, so he walked into the jail and one of the jailer's pulled KH from her cell. The two walked from the jail and into the sergeant's office. Sergeant Ramirez gave KH a Coke and, as he described it, to "butter her up." KH and Sergeant Ramirez talked about her current incarceration and how she may be able to get a reduced bond. Sergeant Ramirez knows KH from previous law enforcement encounters. Sergeant Ramirez planned to gather information from KH and pass the information onto the narcotic's deputy.
 - B. Sergeant Ramirez did not record his and KH's conversation because he didn't want her to feel as if their conversation was a trap or a set up. Sergeant Ramirez knew KH was providing information to the narcotics deputy. Sergeant Ramirez offered KH a cigarette, and the two went outside for her to smoke. Sergeant Ramirez stated he has several sources of information throughout the community. I told Sergeant Ramirez that KH told me she provided oral sex on him and he replied, "that's a fucking lie." When responding, Sergeant Ramirez did not move and kept his hands in his lap. He denied having any sort of sexual relations with KH. Sergeant Ramirez knew about the incident involving KH approximately 5

years ago while she was incarcerated. The reason Sergeant Ramirez did not have another deputy sit in on his and KH's conversation is because he didn't want KH to feel uncomfortable or intimidated. Sergeant Ramirez believes his body worn camera was off when he and KH were talking in his office.

- C. Sergeant Ramirez continued to deny any sexual encounters with KH and denied having sex with KH at Splashway. At the 14:25 minute mark, I explained the sexual allegation that occurred next to Sergeant Ramirez's patrol unit in Rock Island, Texas. Sergeant Ramirez, with his arms crossed, nodded his head up and down and said, "Ok." Sergeant Ramirez did, upon KH's incarceration on 08-29-2024, pull her from the jail. The purpose of this conversation was to see if KH would make narcotics buys for the CCSO. Sergeant Ramirez did confirm he and KH messaged back and forth through cell phones while she was out of custody. According to Sergeant Ramirez, he believed the messages entailed KH's whereabouts. I asked Sergeant Ramirez if there were inappropriate messages on KH's cell phone, and he replied, "I don't think so, no there isn't." Sergeant Ramirez utilized the county's cell phone to communicate with KH. Sergeant Ramirez couldn't recite his county cell phone number. After mentioning the Coke can to Sergeant Ramirez, I explained some of his semen may still be in the bottom of the can. Sergeant Ramirez with his head down, huffed, and said "Jesus Christ, that's fucking crazy." When asked by Chief Lindemann, Sergeant Ramirez stated he wanted to talk to KH in private about his cousin who's allegedly selling narcotics.
2. The interview with Sergeant Ramirez concluded after approximately 35 minutes. For additional and complete details, refer to the audio/video recording. A copy of the audio and video will be kept in my digital case file.

1. As part of this investigation, I, Texas Ranger Cody Rogers, reviewed jail video for the dates of 08-29-2024 and 09-22-2024. I observed and noted the following:
 - A. On 08-29-2024, Colorado County Sheriff's Office Sergeant Tomas Ramirez enters the jail from the hallway at a time stamp of 18:47:12 (camera 05). At a time stamp of 18:48:48, Sergeant Ramirez and KH (Pseudonym) exit the jail. Sergeant Ramirez and KH re-enter the jail at a time stamp of 19:28:12 (camera 05).
 - B. On 09-22-2024, Sergeant Ramirez enters the jail from the hallway at a time stamp of 21:24:37 (camera 05) and walks into the control room. At time stamp 21:49:06, Sergeant Ramirez exits the control room, and KH follows (camera 05). The two exit the jail and enter the hallway at a time stamp of 21:49:15 (camera 05). The two re-enter the jail from the hallway at a time stamp of 22:57:58. Sergeant Ramirez enters the control room and KH continues to her jail cell.
2. The Colorado County Sheriff's Office provided me with a copy of the jail videos for the dates above. A copy of each video will be kept in my digital case file.
3. This investigation continues.

4. I took photographs of KH's jail cell utilizing my State issued Nikon digital camera, then collected the following from jail cell #804:
 - H. Item #9 – Towels from jail cell #804 (Tag #24109606)
5. I photographed the sergeant's office and collected the following:

- I. Item #8 – 12-ounce Dr Pepper can (Tag #24105825)
- J. Item #10 – 2 DNA swabs from office door handle (Tag #24105789)
- 6. Evidence Items #1 through #10 were packaged and secured by CCSO Sergeant Investigator Randy Mican.
- 7. KH's cell phone was removed from her jail property and brought to the investigator's office. I powered on the device and viewed messages between KH and Sergeant Ramirez. I took the device to the Bryan Police Department (BPD), where the BPD's Crime Scene Unit downloaded the device. KH's cell phone download will be documented in a subsequent report.

Document Details:

1. On 09-24-2024, the Bryan Police Department Crime Scene Unit downloaded KH's (Pseudonym) cellular telephone using data extraction software called Cellebrite. I picked up the download on 09-25-2024, and a copy will be kept in my digital case file.
2. I began viewing the "Conversation – Instant Messages" section and "Call Log" list between Colorado County Sheriff's Office (CCSO) Sergeant Tomas Ramirez and KH. According to the Cellebrite download, the instant messages began on 08-23-2024 and concluded on 08-26-2024.
3. On 08-23-2024, at a time stamp of 2:35:12 AM, Sergeant Ramirez sent KH a message that reads "let me see that ass so I can take care of something right now". The messages continue and the two converse about the whereabouts of on duty deputies. Sergeant Ramirez let KH know she has a warrant for her arrest and they communicate about meeting one another. I extracted the messages onto a PDF, and a copy of the PDF is included as an attachment to this supplement.
4. KH called Sergeant Ramirez three times, twice on 08-23-2024 and once on 08-25-2024. Sergeant Ramirez answered the calls on 08-23-2024 and did not answer the 08-25-2024 call. I extracted the call log onto a PDF and a copy of the PDF is included as an attachment to this supplement.
5. I returned KH's cell phone to the CCSO and the device was placed back into her property at the jail.
6. This investigation continues.

Document Details:

1. On 09-25-2024, I, Texas Ranger Cody Rogers, learned from Colorado County Sheriff's Office (CCSO) Chief Deputy Justin Lindemann that Thomas Alan Ramirez resigned his position with the CCSO. Ramirez resigned by leaving a typed note inside his patrol car, left parked at the CCSO.
2. I applied for and was issued a search warrant to obtain Ramirez's DNA. A copy of the signed affidavit, search warrant, and search warrant return are included as an attachment to this supplement.
3. On this date, myself along with Chief Lindemann, and CCSO Lieutenant Jacob Gorman, drove to Ramirez's residence. Lieutenant Gorman activated his body worn camera, and I had a digital recording device as a backup. A copy of the body-worn camera footage and digital recording will be kept in the master file of this investigation.
4. Chief Lindemann greeted Ramirez, and the two discussed his employment with Colorado County. I walked up to Ramirez and respectfully requested a sample of his DNA in, which he refused. Ramirez and I walked to my vehicle, and I handed him a copy of the signed DNA search warrant.
5. I donned a pair of latex gloves and swabbed Ramirez inner cheek and mouth with two swabs. I timed, dated, and initialed the packaging, then secured the DNA sample in my vehicle. Chief Lindemann and Lieutenant Gorman continued to converse with Ramirez.
6. Upon returning to the CCSO, CCSO Lieutenant Andrew Weido searched the marked unit previously assigned to Ramirez. In between the two front seats, written on scratch paper, were the numbers "979-942-7551." I took a photograph of the paper. Ramirez's DNA sample (Item #11) and the scratch paper (Item #12) were secured in an evidence locker at the CCSO. Note: the CCSO maintains chain of custody for the two items.
